

## Deep Brain Reorienting – Participant Agreement

I hereby agree to the following:

1. I am participating in a Deep Brain Reorienting training, workshop, demonstration session, case consultation, or online event (the “Course”) of my own volition and voluntarily agree to the Participant Agreement.
2. I am sufficiently qualified and experienced as a mental health trauma therapist to be capable of participation in the Course.
3. I understand and agree that I will be solely and exclusively liable for all my acts and omissions at all sessions, meetings, and consultations related to the Course.
4. I understand that if I suffer from any health risk or am pregnant and I elect to proceed with the Course, I do so at my own risk.
5. I acknowledge and agree that the Course is exclusive intellectual property of Deep Brain Reorienting (the “Intellectual Property”). I further understand that DBR is the exclusive owner all materials utilised in the Course including, but not limited to, all printed, audio, video, digital, online, and other materials (“Materials”) including any duplications or reproductions.
6. I agree that all personal information of any participant relayed within the Course is strictly and completely confidential. I shall not disclose any of this confidential information to any other person or entity under any circumstances. I shall not make any audio, video, audiovisual, or other recordings of any portion of the Course nor shall I duplicate, reproduce, distribute, publish, or discuss any of the confidential information contained in or related to the Course.
7. DBR shall not be liable or responsible for any unauthorised recording of the Course, nor liable or responsible for the use or exploitation of any unauthorised recordings.
8. I understand that if DBR approves the recording of the Course, or part of the Course, I give permission to be recorded and for the recording to be distributed to other Course participants for learning purposes.
9. If I agree to participate in the Course as the subject of a demonstration, I am doing so voluntarily and at my own risk. I understand that the demonstration session may include questions about my personal trauma history and the emotional, psychological, and physical symptoms I may be experiencing. I further understand that I am under no obligation to participate in the demonstration, that I may refuse to answer any question, and that I may pause or discontinue my participation in the demonstration at any time at my discretion. DBR has no liability or responsibility for my participation or involvement in any demonstration

and I accept that any result or no result may occur due to my participation or involvement.

10. I understand that the primary reason for participating in, and receiving, the Course is educational — to observe and experientially learn how Deep Brain Reorienting principles are applied in practice, to support my professional training and development.
11. I will at all times indemnify and hold harmless DBR, and its agents, from and against any and all claims, actions, damages, costs and expenses related to my acts or omissions in providing services related to the Course.
12. I understand and agree that all my sessions, meetings, and consultations with DBR assistants, trainers and consultants (Providers) are undertaken at my own risk and that DBR does not control, influence, or regulate Providers. I hereby release DBR and its related parties from any and all liability or responsibility for any acts or omissions of any Provider and any claims related thereto. I understand that DBR makes no representations or warranties about the characteristics or quality of the services I may receive.
13. In the event that DBR or its authorised representatives or the Course organiser requests that I discontinue my participation and involvement with a live Course, I will immediately leave the Course and the premises upon which the Course is being held.
14. I acknowledge that I have carefully read this Agreement, I understand its contents, and I understand that this Agreement includes an assumption of risk and release of the Released Parties' negligence and a release of their liability.
15. This Agreement shall remain in full force and effect throughout my education and Course with Deep Brain Reorienting.
